2.2 SECTIONAL OVERHEAD DOORS, EX3700 SERIES

- A. EX3708: Flush Insulated Steel Full View Doors, Thermally-Broken, Polystyrene Insulated
 - 1. Maximum Door Size: 16 ft, 2 inches (4.93 m) wide by 14 ft (4.27 m) high.
 - 2. Panels: Sandwich construction of exterior and interior steel skins pressure bonded to an expanded core, with skins separated by a continuous silicone filling forming a thermal break.

 - 13. Windows: Extruded polypropylene windows measuring 19-1/2 inches by 16 inches (495 mm by 406 mm).
 - a. Glazing: 1/8 inch (3 mm) tempered.
 - b. Glazing: 1/8 inch (3 mm) frosted tempered.
 - c. Glazing: 3/4 inch (19.05 mm) insulated tempered.

- 8. Display: Absolute cycle count, service cycle count, diagnostic messages, and door and operator status via 2 line, text LED display.
- 9. Cycle counter: Resettable via wall controller or myQ technology.
- 10. Limit setting: Electronic pushbutton via wall controller.
- 11. Manual Hoist: Manual hoist with integral manual operation protection circuit.
- 12. Cable Tension Monitor: Mitigates door operation when cable slackening occurs.
